But it's not enough to hand over the literature; our expert move consultants are happy to help customers by explaining the key things they need to know, like telling them they should never sign a blank document. We encourage customers to research, get estimates from at least two other companies, and – above all – ask questions.

Here are some other things to keep in mind:



1 Your moving company should always do a visual survey of your household goods. That can be in-person or virtual using your smart phone. Either way, it's a must.

2 Ask your salesperson about Full Replacement Value Protection (FRVP) — this is the agreement with the van line as to how much your household goods are worth and what will happen if items are damaged during the move. Moving without FRVP coverage means your household goods are only worth 60 cents per pound, per item. Your expensive television that weighs only 30 pounds would be worth less than \$20. Yes, FRVP will cost more, but it's worth the peace of mind. Make sure your salesperson explains FRVP — and if a company doesn't offer it, walk away.

VALUATION PROTECTION
Protecting Your Household Belongings

Valuation protection is the value you declare for your possessions. It is not insurance. It determines your coverage if your belongings need to be repaired or replaced after a move.


